# Section 2 – RLSS Positioning Statement

RLSS will facilitate drowning prevention, lifesaving and lifesaving sport activity under the brand of The Royal Life Saving Society (RLSS). The RLSS will also foster and facilitate exchanges and sharing between RLSS Members and Companion Organizations.

# Section 3 – Our Values

We will foster a commitment to curiosity and continual learning to help us in achieving our tasks

#### **Inclusion**

We will include and embrace organizations and personnel throughout the Commonwealth in achieving our mission

**Important Note:** The idea of a RLSS lifesaving "family" involves member organizations being encouraged to participate in collaborative activities and engage in helping and sharing with others. As a result, member organisations are encouraged to participate in activities, initiatives, and programs across the Commonwealth.

# **Section 4: Advocacy Plan 2022**

# Scope/Purpose:

To elevate awareness and support by the Commonwealth of Nations leadership<sup>2</sup> for drowning prevention, lifesaving, and youth leadership training through the work of the RLSS and its members.

To strengthen the RLSS contributions within the global drowning prevention effort.

## **Key Strategies:**

## **Capacity building:**

The Advocacy Plan framework will be useful to inform action decisions.

Advocacy activity expansion will recruit new resources, skills, and collaborations.

Impact assessment and evaluation of advocacy activities will be done to build knowledge and capacity.

#### The Tasks:

## Providing clear messaging to support RLSS drowning prevention activities:

- 1. Conduct and/or partner in a range of advocacy events, campaigns and initiatives that progress drowning prevention issues across the commonwealth, globally, regionally and nationally through our members and key stakeholders.
- 2. Promote and facilitate the collection, analysis, and dissemination of fatal and non-fatal drowning data by Commonwealth countries to tell the stories of drowning burden and prevention success.
- Create and disseminate drowning prevention factsheets that outline key drowning prevention issues, including drowning burden, prevention measures, research themes, and global, regional, national and local strategies.
- 4. Develop and disseminate evidence and stakeholder informed key messages that cover commonwealth nation drowning burdens, the need for multi-sectoral collaboration and urgent local action.

## **Utilizing the UN Resolution on Global Drowning Prevention:**

- 1. Amplify and disseminate the UN resolution amongst membership and Commonwealth entities.
- 2. Encourage members to review how they can contribute to national efforts to respond to voluntary actions, and engage, drive and contribute to national or regional activity.
- Support and actively commemorate UN World Drowning Prevention Day on July 25<sup>th</sup> annually.
   (Including dissemination of information materials/core messaging to members, collective voice /representation role with global partners and to document these activities and the impacts)
- 4. Investigate and map the relevant alignments that the RLSS has with the Commonwealth Charter, Commonwealth Foundation, UN Resolution on Global Drowning Prevention, and the Sustainable Development Goals (SDGs).

## **Building partnerships with aligned organizations:**

- 1. Undertake a partnership review of key drowning prevention organisations, for example, with UN Key Agencies, governments, academic institutions, industry, and NGO sector.
- 2. Evaluate and select potential partnerships that align with the RLSS Vision, Mission and Strategies for maximum impact.
- 3. Invest effort to advance two of the selected strategic partners.
- 4. Expand to further collaborations using learning from the first identified partnerships.

## Advancing the RLSS Friends Network:

The purpose of the RLSS Friends Network is to share information and inspire engagement in RLSS activities. Recognizing that drowning prevention, RLSS capacity and youth leadership development will be improved with collaboration and engagement of role models, mentors and knowledge keepers and that sharing and exchange are important values and tools for education and growth:

- 1. Develop the RLSS Friends Network (refer Appendix).
- 2. Include past and present leaders from the RLSS, Commonwealth, Government, High Commissioners, staff and volunteer from aligned organizations, industry, academics, investors, and donors.
- 3. Include organizations and entities that will add value through collaboration and sharing.
- 4. Invest to create the RLSS Friends Network and provide a regular communication channel / route that is helpful to the RLSS and the RLSS Friends.

## Strengthening the connections arising from the RLSS Royal Charter

The RLSS Royal Charter is a governance document, that brings Patronage, Presidency, prestige, and recognition which can be used in Commonwealth countries<sup>3</sup>, to advance the RLSS mission.

- 1. Engage Board appointed contributors to explore opportunities for elevated awareness, acknowledgement of achievements, connections with governments and intergovernmental agencies
- 2. Identify, based on willingness, availability and impact assessment, appropriate engagement with Royal connections in RLSS and RLSS Member Organisation activities, and then conduct targeted communication and lobbying.
- 3. Accepting the beneficial impact of Commonwealth President and Royal Patronage, continue to brief and engage them in RLSS activities and in succession planning activities where possible and appropriate.
- 4. Consider existing or new honours and innovative awards that would be suitable for the Commonwealth President and Royal Patronage participation in the form of communication, presentation or titling.
- 5. Induct the Commonwealth Council, Board of Trustees, volunteer Directors, and staff in RLSS advocacy biennially such that they become lead ambassadors for RLSS.

## **Definitions:**

**Advocacy:** is an activity by an individual or group that aims to influence decisions within political, economic, and social institutions. Advocacy includes activities and publications to influence public policy, laws and budgets by using facts, their relationships, the media, and messaging to educate government officials and the public.

**Aligned organizations:** in this context can be defined as sharing a common vision of drowning prevention, lifesaving, and youth leadership training.

**Strategy:** a plan of action or policy designed to achieve a major or overall aim.

**Task:** is an activity that needs to be accomplished within a defined period of time or by a deadline to work towards a strategy or goal.

### Terms of Reference - RLSS Friends Network -

Friends can be people, organizations, government agencies, industry, academics and/or civil society leaders.

Friends will be connected by interest and the desire to add value to the work of the RLSS in drowning prevention, lifesaving, and youth leadership training.

Friends will receive key update and progress communication reports 2 times per year.

Friends may be asked to assist with connections, knowledge sharing, alignments, advice, education, inspiration, and mentorship, occasionally.

Friends will be invited to the RLSS Friends Network and can withdraw if they wish.

The RLSS Friends Network will require an honorary/volunteer chair and some staff support for communication.

The Role Description for the RLSS Friends Network Chair or Portfolio (honorary/volunteer)

To report to the Advocacy effort within the RLSS Board of Trustees.

To facilitate and coordinate the activities outlined in the RLSS Advocacy Plan, RLSS Friends Network Strategy.

To make recommendations to update the RLSS Advocacy Plan, RLSS Friends Network Strategy, when needed.

To provide leadership by seeking opportunities for the Friends Network to add value to the work of the RLSS.

To provide or determine a process to provide leadership chairpersons for activities within the RLSS Friends Network.

To ensure that a communication is sent to the RLSS Friends Network on a regular basis.

To utilize social media as an efficient and connecting tool to share knowledge with the RLSS Friends Network.

To provide leadership to the content and timing of communications to the RLSS Friends Network.

To recommend and welcome invitees to the RLSS Friends Network.

To ensure that new invitees have some orientation to the RLSS, the RLSS Strategic Plan and Advocacy Plan.

To keep a register of the RLSS Friends Network and to thank those who complete their contribution to the RLSS Friends Network.
